 - o Parents may access real-time updates through Parent Portal/ASCENDER.
- Ensure reasonable access to school staff for parents. Staff will be available for consultation during planning periods, scheduled parent-teacher conferences, and through ParentSquare, email or phone during normal hours.
- Deliver instruction in a way that motivates and encourages student success.

- Teachers will contact the parents of the students in their classes through notes, emails, conferences, progress reports, ParentSquare or telephone calls to show an active interest in the success of their students.

- Ensure that homework is completed.
- Encourage positive use of extracurricular time.

- Participate in decisions relating to our child's education when appropriate.
- Stay informed by reading communications from the school (received by note, mail, or ParentSquare) and responding promptly when necessary.
- Serve on advisory groups when possible, such as the Title I, Part A Policy Advisory Committee, School Improvement Team or other school/district advisory councils.
- Provide a nurturing home environment that supports learning.
- Designate a quiet space and time for reading and study at home.
- Support our child in meeting his/her responsibilities by encouraging appropriate behavior and homework completion.
- Communicate regularly with teachers (by notes, conferences, or telephone calls) to stay informed about academic progress.
- Attend at least one parent involvement activity (e.g., literacy nights, parent meetings, or site-based decision making meetings).
- Review newsletters and other school communications regularly.

- Spending time daily on studying and reading at home.
- Sharing all school communications and notices with my parents or guardians promptly.
