- 2.) Used an alternative assessment tool, but did not submit proper documentation to TEA, or
- 3.) Had five or more students that were not assessed



Beginning in the 2019-2020 school year, all eligible four-year-old students must be assessed using a tool from the Commissioner's List of Approved Prekindergarten Assessment Instruments. An alternative tool may not be used with eligible four-year-old students.

TEACHER QUALIFICATIONS

Requirement: Prekindergarten teachers serving eligible four-year-old students must be appropriately certified to teach prekindergarten and have an additional qualification.
